

## Post-War Incidents\*

### *August*

1. On 13 August, Ossetian militiamen assaulted the representatives of “Cartu Bank” in the town of Gori and took away their vehicle Ford Expedition.
2. On 13 August, at about 13:00 five Russian-speaking soldiers assaulted Kakhaber Nadiradze (b. in 1979, resident of Chiatura) in the town of Gori, taking away his vehicle Jeep Pajero and other belongings.
3. On 13 August, seven Ossetian paramilitaries assaulted Ivane Elizbarashvili (b. in 1974, resident of village Teleti, Gardabani district) near village Karaleti and took away his vehicle Opel-Vectra.
4. On 13 August, several Ossetian paramilitaries robbed Teimuraz Turazashvili (b. in 1956, resident of Tbilisi), abducting his Volkswagen Golf vehicle.
5. On August 13, two individuals assaulted Ervand Chegelidze (b. in 1952, resident of Gori), abducted his vehicle Opel-Vectra No: AMA-845.
6. On August 13, near village Shavshvebi, armed individuals in military uniforms assaulted Malkhaz Natriashvili, (b. in 1964, v. Kveshi resident), abducting his vehicle Opel-Astra No: BOI 785.
7. On 13 August, two Russian-speaking soldiers stopped a minibus in Gori, robbed its driver Merab Dzotsenidze (b. in 1961, resident of Tbilisi) of 3500 GEL and took away his Mercedes Benz minibus.
8. On August 13, armed criminals attacked Temur Iakobashvili, (b. in 1952, resident of v. Kvemo Khvedureti) near village Doglaura on a central highway. Iakobashvili was driving his Opel-Vectra No: ILO-503. Temur Iakobashvili has been injured and then robbed.
9. On August 13, in village Breti area, six unidentified armed Ossetian criminals hijacked a jeep “Grand-Cherokee” (MHM-970), property of a Georgian company “Rus-Energo.”
10. On August 13, “UAZ” type vehicle No: PSP-452 belonging to Ltd “Gori Emergency Service 03”, was stolen from the Gori Military Hospital area.
11. On August 14, the house of Mediko Sukhitashvili, resident of village Karaleti, was burned.
12. On 15 August, six Russian-speaking soldiers assaulted Nikoloz Khmiadashvili (b. in 1961, resident of Gori) in village Rekha, Gori district and took away his Vaz-21011 vehicle.
13. On 16 August, armed Ossetian paramilitaries stopped Vazha Kopadze (b. 1959, resident of village Dvani, Kareli district) in village Breti, Kareli district and took away his Vaz-2103 vehicle.
14. On 16 August, armed Russian speaking soldiers robbed Temur Saakashvili (b. in 1958, resident of Tbilisi) near village Mejvriskhevi, Gori district, taking away his Vaz-2103 vehicle.
15. On August 16, a flat was robbed in Gori on Tsereteli St. no. 2, which belonged to Sonia Bitadze (b. in 1969, resident of Gori).
16. On August 18, cornfields in village Dzevera, belonged to Nona Bukhradze (b. in 1969, resident of Ninoshvili st 102) were burnt down.

\* This is an incomplete list of illegal activities and cease-fire violations by Russian troops and proxy paramilitaries. The MIA continues to receive reports on earlier and latest incidents both within and near the conflict zones.

17. On August 18, armed Ossetians assaulted Nugzar Gamgebeli, (b. in 1956, resident of v. Kelktseula, Gori district), abducting his vehicle Opel-Astra No: HYH-682.
18. On August 20, a shop was robbed at Shindisi highway no.7, which belonged to Amiran Khakhutashvili (b. in 1962).
19. On 24 August, Russian soldiers stopped a Nissan car in Poti, which belonged to the Caucasus bureau of Associated Press, kidnapping journalists Davit Pipinashvili (citizen of Georgia) and Raul Galego (citizen of Spain). After negotiations between Russian officers and Georgian police, they were released.
20. On August 24, Ossetians and Russians robbed a shop in Gori, Vologda district.
21. On August 24, Nanuli Makrakhidze (registered at Muskhelishvili st. 54, Gori) was killed by the bomb explosion near the military base in Gori, Tsmindatskali area.
22. On August 24, Russian-Ossetian group stole a car "Golf -3" (JIM-105), belonged to Jimsher Kachidze (b. in 1979, v. Kvibisi resident) in village Rekhi, from Badri Karelashvili's household.
23. On August 24, in village Koshka, Abe Gobozov, resident of v. Khelchua shot and injured 2 residents of village Koshka Guram Javakhi, (b. in 1938) and Arkadi Tatiuri (b. in 1961).
24. On August 25, near the railway station in Khashuri, the body of Zviad Turmanidze (b. in 1981, the resident of v. Kvenatkotsa, Kareli region) has been found. The body had traces of several heavy injuries.
25. On August 25, Ossetians in military uniforms injured George Kasradze, (b. in 1941, v. Ergneti resident).
26. On August 25, Nodar Kareli (b. in 1953, v. Tkviavi resident), stepped the bomb that exploded. He was taken to hospital, where he was provided with corresponding treatment.
27. On 25 August, Russian soldiers insulted and beat up Georgian police officer Ramaz Jvania (b. in 1979) in Poti. Currently, Jvania is undergoing medical treatment.
28. On August 26, an unidentified dead body of a male was found in village Shindisi, Gori district;
29. On August 26, Zaza Tsereteli, (b. in 1985, v. Ergneti resident) declared that he was injured by Ossetians near the public school 3, Amilakhvari st.
30. On August 26, Ossetian proxy authorities released Tamaz Sirbiladze's children, who were kidnapped during the war. The children were tortured and beaten. Tamaz Sirbiladze is the resident of village Variani, Gori district.
31. On August 28, Ossetian proxy militia stole cattle, which belonged to Mikheil Ginturi (b. in 1939, v. Mejvriskhevi resident).
32. On 30 August, Ossetian paramilitaries kidnapped four Georgian beekeepers from a beekeeping farm in the Dzirula valley. Their whereabouts are still unknown.
33. On 30 August, armed Ossetian paramilitaries stopped Nugzar Gamgebeli (b. 1956, resident of village Kelktseuli, Gori district) in village Shindisi, Gori district and took away his Opel-Astra vehicle.

## *September*

34. On 1 September, four armed Ossetian paramilitaries attacked the house of Kvinikadze family in village Abanos Koda, Kareli district, killing Nora Kvinikadze (b. 1936), injuring her son Giorgi Kvinikadze (b. 1962) and her grandson Raul Kvinikadze (b. 1988).
35. On 1 September, unidentified individuals injured Nodar Berkenashvili (b. in 1953, v. Shindisi resident).
36. On 1 September, a cow belonged to Zurab Makasarashvili (b. in 1943, resident of v. Marana) was stolen.
37. On 2 September, two Russian soldiers and four Ossetian paramilitaries, driving an armored vehicle, approached the Georgian police checkpoint in the village Akhalubani, Gori district. They threatened the Georgian police officer: Badri Gogidze, Emzar Ghonghadze, Kakhaber Metreveli, Mamuka Maisuradze, Shalva Nebieridze, Ivane Datashvili, Ioseb Melanashvili and Levan Gigauri and took away their rifles and Makarov pistols. They also abducted their Toyota police vehicle and Ford vehicle of passer-by Ilia Mighrajanashvili (b. 1984, resident of village Akhalubani).
38. On September, 3, unidentified individuals stole cattle belonged to Iakob Begeluri, resident of village Disevi, Gori district.
39. On 8 September, Russian soldiers and Ossetian paramilitaries detained two Polish TV journalists Dariush Bokhatkevich and Martin Vesolovski, as well as their driver Levan Guliashvili near village Karaleti, taking away their cameras and car. On 9 September, they were released.
40. On September 8, Nodar Tatulashvili, born in 1960, v. Plavismani resident was wounded with a knife in the breast area. The accident took place in Plavismani.
41. On September 9, Zhora Finavriti (b. in 1938, the resident of v. Brostleti), was injured after a bomb exploded in his own orchard in v. Brostleti, Gori district.
42. On 10 September at about 10:15, Ossetian paramilitaries opened fire from the Russian checkpoint at Karaleti, wounding one Georgian police officer Kakha Tsotniashvili, who later died at the hospital.
43. On September 10, Zaza Pavliashvili, (b. in 1970, v. Dzevera resident) was injured in his village.
44. On September 10, Vasil Javakhishvili, (b. in 1938, v. Ksuisi resident) was injured by Ossetians in his village.
45. On September 11, Ossetian proxy militia brutally beat up Mikhael Tukhareli (b. in 1940, in v. Disevi, Gori district). Later Ossetians robbed him and burned his house down.
46. On September 11, "Ford" (private vehicle) was stolen in Gori, parked at Stalin Street.
47. On 12 September, Ossetian paramilitaries burned nine houses of ethnic Georgians in village Eredvi, Little Liakhvi Valley.
48. On 12 September, Ossetian paramilitaries beat up Vasil Javakhishvili, an ethnic Georgian living in village Ksuisi, Tskinvali district.
49. On 13 September, Ossetian paramilitaries kidnapped 6 residents of villages Disevi and Koshka of Gori district, poured gasoline on them and threatened to burn them alive if they did not abandon their villages.

50. On 13 September, Abkhaz paramilitaries opened fire towards village Ganmukhuri, Zugdidi district, killing one Georgian police officer Besik Khulordava.
51. On 15 September, at 13:45, seven armed Ossetian paramilitaries stopped a Georgian minibus near village Mereti, Gori district, beat up the driver and his companion, vandalized the vehicle and threatened to “burn the bus together with its passengers” if seen again in this area.
52. On 15 September, Ossetian paramilitaries looted and then burned down the houses of Vladimer Bolashvili in village Ditsi, Gori district and Jimsher Lomsadze in village Zemo Nikozi, Gori district.
53. On 16 September, Ossetian paramilitaries opened fire towards residents of village Brotsleti, Gori district who were working in their orchards and had to flee back to their houses. Fortunately, no one was hurt.
54. On September 16, Emir Mindiashvili, (b. in 1958, v. Ditsi resident) has been injured by Ossetians in his village.
55. On 16 September, at 13:30 six armed Ossetian paramilitaries entered village Ditsi, Gori district, robbed the house of Jimsher Markozashvili, shot in the air to frighten the local residents and severely beat up one of them - Emir Mindiashvili (aged 51).
56. On 16 September, at 15:00 Ossetian paramilitaries devastated the farm owned by Otar Koniashvili in village Kveshi, Gori district, stealing its livestock.
57. On 17 September, Ossetian paramilitaries robbed the farm owned by Gocha Giunashvili in village Kveshi, Gori district, assaulting its guard and stealing its livestock.
58. On September 18, two cows were stolen by Ossetians, belonged to Suliko Gigauri, (b. in 1931, resident of v. Kitsnisi).
59. On 18 September, at 12:00-14:00, five Ossetian paramilitaries robbed the houses of Tamaz Kopadze and Gocha Korashvili in village Dvani, Kareli district and then put these and several other houses on fire.
60. On September 19, near village Megvrekisi, two Ossetians hijacked Opel No: BOI-598 belonged to Bondo Chubinidze, (b. in 1971, resident of Gori, Gorgasali st. 14) The Ossetian criminals stole his and his passenger David Chubinidze’s (b. in 1970, resident of Gori, Sukhishvili st. 63) cellcell phones
- September 20, Vepkhia Gegelashvili, born in 1973, v. Khvedureti resident was injured by unidentified individuals.
61. On September 20, Vepkhia Gegelashvili, born in 1973, v.Khvedureti resident was injured by unidentified individuals;
62. On September 21, George Melnikov, born in 1986, v. Variani resident was injured by a bomb left by Russian occupants in his own garden. The bomb exploded and he received major injuries.
63. On 21 September, at about 19:00, Abkhaz paramilitaries opened fire towards village Khurcha, Zugdidi district, killing one Georgian police officer Ramaz Kitia and wounding three more.
64. On 21 September, Ossetian paramilitaries burned four houses owned by ethnic Georgians in village Muguti, Znauri district.

65. On 22 September, two Georgian police officers were wounded in the result of mine explosion in village Khurcha, Zugdidi district. Currently, they are undergoing medical treatment. The mine was apparently left there by Abkhaz paramilitaries, who withdrew from the village earlier.
66. On 22 September, Abkhaz paramilitaries kidnapped 15 year old Irakli Dzhalongia from village Zemo Barghebi, Gali district and are demanding a ransom of 50 000 USD from his family.
67. On 22 September, Georgian police officers saw a Russian UAV above villages Khurvaleti and Tsitelubani, Gori district, which was taking photos of Baku-Supsa oil pipeline. The UAV was shot down.
68. On 24 September, Abkhaz paramilitaries kidnapped four ethnic Georgians Papuna Karaia (b. in 1980), Bezhan Ubiria (b. in 1980), Gogita Kvirivia (b. in 1983) and Badri Akhalaia (b. in 1978) from village Otobaia, Gali district. They were released on the next day only after their families paid the ransom demanded by the kidnappers.
69. On 25 September, at about 17:15, fifteen armed Ossetian paramilitaries driving a UAZ type truck assaulted the workers of road building company "Ashtrom" at a sand quarry near village Orchosani, Akhagori district, taking away their belongings and the company's "Ford-Transit" minibus.
70. On September 25, in village Kitruli, the Ossetian criminals robbed Zurab Dotiashvili, resident of v. Kirbala, and stole 46 cows.
71. On September 26 at night, Ossetian militiamen entered village Vanati (Jojiaant settlement) and burned the remained houses.
72. On September 27, 3 Ossetians dressed in military uniforms, driving "Niva" entered village Zemo Nikozi. They were forcing local population to accept Ossetian passports, otherwise they would be forced to leave the territory and their houses were promised to be burned.
73. On September 29, Ossetian militiamen robbed the houses of Sandro Iluridze and Vazha Gelashvili in Akhagori.

### ***October***

74. On 2 October, Ossetian militiamen entered village Kere, they were menacing local population using machine guns and burned one house.
75. On 3 October, in town Gori, nearby the military base, two teenagers, Vaja Elbakidze and George Maisuradze were injured by mine explosion.
76. On 3 October, at 10 o'clock in the morning, Russian militaries were disseminating proclamations in Georgian villages Chuburkhinji, Pichori and Otobaia of Gali district.
77. On 3 October, Russian militaries occupied the premises of village Lukhori school, started digging trenches and mining the adjacent territories. The study process has been ceased in this school.
78. On 4 October, in villages Megvrekisi and Ergneti, Ossetian gang headed by so called "Tklipliani" (other details are not known) were looting and searching houses. They were using Mitsubishi Pajero and "UAZ" cars with no number plates.
79. On 5 October, at 3:30, one police officer was injured after fire was opened from the direction of the Russian checkpoint in village Variani.

80. On 6 October, Russian militaries were demanding alcohol from the Gegerdava family in village Sida of Gali district. They insulted the members of this family and shot Mindia Gegerdava to death.
81. On 6 October, at 00:50, in village Pakhulani of Tsalenjikha district, 2 mortar shells (82 mm) were dropped near the highway, fired from the territory of Abkhazia. At 07:10, 2 shells of the same caliber were dropped in the centre of village Pakhulani, in 200m east from river Ilori.
82. On 6 October, at 8:20, in the adjacent area of Enguri dumb, a Russian army “Ural” type heavy truck, drove to the direction of village Jvari, when the EUMM monitors heard the noise caused by explosion.
83. On 6 October, Ossetian militiamen stopped 9 EUMM monitors, who were conducting their mission in 2 vehicles and 2 Belgian journalists. Their personal belongings, money, equipment and mobile phones were stolen.
84. On 9 October, Ossetian militiamen beat Omar Kasradze, the resident of v. Ergneti, who was taken to the Gori hospital.
85. On 9 October, in village Mosabruni of Akhagori district, the servicemen of Ossetian Ministry of Defense separate mountain battalion (Bala Betsauti is the commander) opened fire and robbed the house of a local resident.
86. On 10 October, the residents of village Satikhari of Tskhinvali region once again robbed the school in village Ksuisi, the expensive heating equipment donated by the UN has been stolen.
87. On 11 October, 3 Russian fighters violated Georgian airspace. For half an hour, they were flying over the territories of Gori, Tskhinvali and Akhagori.
88. On 12 October, at 10:49, in village Zemo Nikozi, 2 mines with time mechanism exploded at a 15 min interval.
89. On 12 October, Ossetian militia looted the house of Aleksishvili family in village Boli of Akhagori district.
90. On 13 October, Russian planes violated Georgian airspace twice: at 09:57, 2 planes crossed air border near Staphanstsminda, at 10:29, 3 military planes entered Georgian airspace and flew over the territories of Oni, Sachkhere, Java, Tskhinvali and Kazbegi.
91. On 14 October, near village Dadianeti Ossetian Militiamen kidnapped a 12-year-old boy and were requesting ransom.
92. On 15 October, in village Sakasheti a local resident was killed after the explosion of a mine left over by the Russian occupants, another civilian Genadi Kiknadze received serious injuries.
93. On 15 October, at 12:30 a Russian Military helicopter entered from the direction of Gromi valley, flew over village Mejriskhevi and left towards Akhagori.
94. On 15 October, in villages Kekhvi, Kurta, and Achabeti Ossetian looters divided the properties and lands of Georgians and are harvesting their crops.
95. On 16 October, Ossetian militiamen kidnapped a herdsman and his cattle from village Zemo Nikozi.
96. On 16 October, Ossetian proxy militia stole cattle from village Korinta, Akhagori district.

97. On 16 October, Ossetian proxy militia detained two local Georgians while they were cutting woods near village Akhmaji, Akhagori district. The Ossetians stole their two "ZIL-131" vehicles and electric saws
98. On 16 October, at the adjacent territory of village Zemo Khviti of Gori district four Ossetians attacked inhabitants of the village – Giorgi Lazarashvili (b. in 1943), Giorgi Gogishvili (b. in 1957,) and Jumber Ergemlidze; they hijacked Lazarashvili's vehicle "Mitsubishi-Montero" (OOO-010) and stole 56 cows; Later, Lazarashvili, Gogishvili and Ergemlidze were released.
99. On 16 October, Ossetian paramilitary forces entered villages Zardiaantkari and Gugutiaantkari of Gori district and burned the remaining houses.
100. On 17 October, at night Ossetians opened fire from automatic rifles at village Nikozi, Gori district.
101. On 18 October, in the morning, Russian UAV was flying over village Nikozi, Gori district. Later it left in the direction of Tskhinvali.
102. On 18 October, Ossetian proxy militia shut down a water pipeline from Patara Liakhvi gorge towards Gori district. As a result, 17 villages of Gori district were left without water.
103. On 18 October at about 03:30 p.m., Ossetian proxy militia exploded the bridge of village Adzvi, Gori district.
104. On 18 October, the Ossetian proxy militia closed and took away an electric transformer from the village Zemo Okona, Znauri district, aiming to force Georgian population out of the village.
105. On 19 October, at 07.00 the fire, including from mortars, was opened from the Abkhazian side towards village Khurcha. One house of a local resident was significantly damaged.
106. On 19 October, at 5.30 a.m., Abkhaz proxy militia exploded the bridge connecting village Tagiloni of Gali district with village Shamgona, Zugdidi district.
107. On 21 October, Georgian police car was blown up by a remote controlled mine in village Avlevi of Kareli region, as a result one policeman Giorgi Pertenava was wounded.
108. On 21 October, 40 armored vehicles and several hundreds of Russian soldiers entered the territory of Akhagori district from Tskhinvali.
109. On 21 October, Russian occupants did not allow the pupils from village Saberio, Gali district to go to school in Tsalenjikha. About 60 children were left without access to schools.
110. On 21 October, a remote controlled bomb exploded in a mess of village Chegali. The building where the mess is located is used by Russian occupants. This mess has been frequently visited by Georgian workers and presumably, the explosion targeted them. A cook working at this mess was injured.
111. On 23 October Ossetian paramilitary forces detained Beka Kalandadze (b. in 1979) and Lasha Tsintsadze (b. in 1989), the residents of village Muguti, Znauri region. They were released later.
112. On 24 October, in village Khurvaleti, Gori district, Ossetian proxy irregular forces attacked the delegation of Georgian Ministry of Education, which visited the local school. Ossetians tried to seize their vehicle and personal belongings, but the locals helped the delegation.

113. On 24 October, at 10:00 a.m., Abkhazian proxy militia exploded the railway bridge connecting villages Shamgona and Tagiloni.
114. On October 25, at 1:15 a.m. and 9:00 a.m. mortar shells were launched from Abkhazian territories to village Mujava, they damaged the house of Otar Sabulua.
115. On 25 October, when governor of Tsalenjikha region Gia Mebonia was inspecting the house which was attacked the night before, the mine exploded, killing him and wounding owner of the house Otar Sabulua and policeman Zviad Lagvilava. Otar Sabulua has also died of injuries.
116. On 25 October, Ossetian proxy militia appropriated two buses, belonging to Georgian drivers. These buses were donated to Akhagori for local purposes by Georgian President.
117. On 26 October, in village Artsevi of Tskhinvali region the representatives of proxy Militia detained the members of the EU Monitoring Mission and later released them.
118. On 26 October, Ossetian proxy authorities expelled Givi Mamamtavrishvili together with his four family members and Anastasia Gigauri together with her two family members from their houses in village Ikoti of Akhagori district for not knowing Ossetian language.
119. On 27 October, the body of 19-year-old Alikha Khuntsaria was found in the well in village Gudava of Gali district. According to the testimonies of the witnesses, Khuntsaria was stopped by Russians at the checkpoint and verbally abused for carrying Georgian ID. Later he was found murdered.
120. On 27 October, Russian occupants demanded from local population to clean the territory of local graveyard, where they plan to place military installation.
121. On 28 October, Abkhazians and Russian occupants mined all the shores of river Enguri, which are used by local Georgians for crossing and accessing Georgian controlled territories.
122. On 28 October, Ossetians kidnapped 6 inhabitants of village Zerti from forest near village Kirbali of Gori district;
123. On 29 October, the security guard of school no.1 of settlement Akhagori, Tamaz Varduashvili found a bombshell in the schoolyard, which exploded in his hands. The injured man was taken to Tbilisi Ghudushauri Hospital.
124. On 29 October, in village Ghumurishi of Gali region, 28-year-old Linda Shakaia exploded on a mine, which was left there by the Russian occupants. As a result of the explosion, Shakaia lost upper limbs.
125. On 30 October, Ossetian proxy militia opened fire at a Georgian police checkpoint in village Ergneti from Tskhinvali, the fire continued for 20 minutes.
126. On 31 October, Ossetians exploded the bridge near Gori connecting two villages Kveshi and Zemo Artsevi.
127. On 31 October, Ossetians arrested the journalists of Georgian Public Channel, who were preparing the broadcast regarding the explosion of the bridge near Artsevi. Later the journalists were released.
128. On 31 October, in village Largvisi Ossetian militia appropriated several sheep belonging to shepherd Nugzar Shermadini, who resisted. Ossetians killed his remaining sheep using machine gunfire.

129. On 31 October, Abkhazian proxy authority established a curfew restricting the movement of civilians and transport after 22:00. They check passports of local residents. 8 persons have been arrested for violating this regime.

### *November*

130. On 1 November, Georgian police arrested Jacob Tekhov, resident of village Disevi, for caring a hand grenade F-1.

131. On 1 November, Russian occupants exploded 3 bridges in Gali, near villages Khurcha and Nabakevi. The movement of the local population is restricted, as well as all the connecting routs to Georgian controlled territories is mined.

132. On 1 November, the resident of Akhagori Nodar Basharuli was abused in his own shop by Ossetians. They also opened fire at his shop, stole alcoholic drinks and food from the shop. Basharuli was forced to move to Georgian controlled territory and ask the Georgian authorities for assistance.

133. On 2 November, 6 Georgians were kidnapped from the forest near village Kirbali, Gori district. On 11 November, they were released.

134. On 4 November, the 43-year-old Koba Dahkoshvili was kidnapped from village Kvemo Khviti, who has escaped the next morning.

135. On 5 November, fire was opened from Tskhinvali towards Georgian checkpoints near village Zemo Nikozi.

136. On 5 November Alik Gigolaev, the resident of village Zemo Artsevi was killed by unknown persons near village Korkula.

137. On 5 November, Russians robbed the house of Nino Tsinamdzgvrishvili, the resident of v. Kanchaveti, Akhagori district.

138. On 5 November, Ossetians robbed the house of Givi Tatunishvili in village Kanchaveti, Akhagori district. The owner has been beaten up and his cattle stolen.

139. On 6 November, the house of Mstkheta-Mtianeti Governor Tsezar Chocheli was robbed in Akhagori by the head of the proxy militia (police) Iliia Khubulov. He stole wooden construction material using the truck belonging to Anzor Bestaev (nicknamed “Khiva”).

140. On 6 November, 23.00, Ossetians opened fire from village Disevi towards Georgian village Koshka. The fire did not cease for about an hour.

141. On 6 November, Ossetians arrested Zurab Kobaladze in village Avnevi, Znauri district. The person is mentally unhealthy. Kobaladze was placed in isolated cell in Tskhinvali KGB building.

142. On 6 November, 3 anti-tank mines were found on a footpath connecting Gali district village Tagiloni to village Shamgona in Zugdidi district.

143. Georgian population of Gali is leaving their homes. From the 40 remained families of village Nabakievi, 10 have left within few days in the beginning of November.

144. On 7 November, Abkhazian proxy authority started seizing IDs, passports and other documents from Georgian population in Gali district.

145. On 7 November, Abkhazian proxy irregular forces demanded 500 GEL for the release of a 70-year-old Dzadzamia, who was arrested with allegation of illegally crossing so-called Abkhazian border.
146. On 7 November, Abkhazians arrested Giga Dgebuadze and Zuri Jobava, who were visiting their relatives in village Otabaia of Gali district. They were seized of their Georgian passports and taken to Gali police.
147. On 8 November, a group of 50 Ossetian militia opened a checkpoint in village Perevi, Sachkhere district.
148. On 8 November, Abkhazians started to collect food for Russian occupants from Georgian population of village Chuburkhinji and Saberio. The extortion was conducted by the head of local administration Anzor Kirtadze and representatives of Russian Ministry of Defense. Local population is unable to resist
149. On 8 November, Abkhazians arrested 8 Georgians and accused them of illegal crossing of border, carrying arms and narcotics. Border is closed and all the passes are controlled. Only the members of International Organizations and personnel working on Enguri plant are allowed to enter Abkhazian controlled territories.
150. On 10 November, at 07.15, in village Dvani, Kareli district 2 policemen Imeda Kakhniashvili and Tamaz Khachapuridze died of a mine explosion while patrolling; the mine was put the by Ossetian militia. The group of police officers arrived to the site for assistance, but this group also exploded on a remote controlled bomb. 3 police officers were wounded: Giorgi Shubitidze, Giorgi Mdinradze and Enis Jonidava.
151. On 11 November, the bus connecting village Zemo Bargebi to Zugdidi has been stopped by Abkhazians. Later the drivers were called to Abkhazian police and asked to pay permanent taxes for traveling to Zugdidi
152. On 11 November, several residents of Gali district were arrested for illegally crossing Enguri river (bridge is exploded) near village Tagiloni. They were forced to pay 10-15 thousand rubles and those who were unable to pay were taken to Gali police.
153. On 12 November, the Russian occupants (Chechen and Armenian soldiers) beat up 3 Georgian youngsters in Gali district, who were taken to hospital.
154. On 13 November, the Abkhazian police officers of Tkvarcheli district started to seize Georgian IDs and mobile phones from Georgian population. They arrested 2 members of Tsokolia family, who were taken to Tkvarcheli police.
155. On 14 November, the mine explosion killed cattle in village Mujava, Tsalenjikha district.
156. On 15 November, Abkhazians opened fire towards Georgian police patrolling near village Kalagali (close to Pakhulani). One Policeman Zurab Jejelava died of injuries. Fire was reopened when EU monitors arrived to the site.
157. On 16 November, Ossetian militia arrested Khashuri residents Tristan Gugutishvili and Vasil Simonishvili near village Kirkula, Tskhinvali district. They were released the next morning.
158. On 16 November, a Russian UAV was found near village Kere, Gori district.

159. On 17 November, another Russian UAV was found in village Plavi, Gori district; population called police and the group of deminers arrived at the site. After their arrival the remote controlled mine attached to the UAV exploded and killed 2 deminers Giorgi Skhvitaridze and Marat Nozadze. 8 more police officers were wounded as well as a 10-year-old kid who stood close to the site.
160. On 18 November, in village Ksuisi of Tskhinvali district Ossetian militiamen killed Ramaz Shoshitaishvili.
161. On 20 November, at 06.45 a.m., two Russian armored vehicles entered village Ganmukhuri from Otobaia, followed by armed militants. They opened fire at the Georgian police checkpoint in Ganmukhuri from machine guns, mortars, grenade launchers and armored vehicles. The fire lasted for about 15 minutes. The fire damaged the house of local resident Gogeli Pertaia. The occupants mined the road from Ganmukhuri to Otobaia. The second incident occurred at 10:30 when Russians opened intensive fire from mortars to Georgian checkpoint in Ganmukhuri. Fire lasted 5 minutes. EUMM monitors pictured 2 combat helicopters flying over Ganmukhuri on a lower altitude when they visited the site of the accident.
162. On 21 November, Ossetians exploded the radio transmission tower and station in village Chorchana of Khashuri district. This station and tower were previously used for Baku-Supsa pipeline operation.
163. On 23 November, at around 6:15 p.m., the Russian occupational forces stationed near village Odzisi, Akhagori district opened fire as the motorcade of the President of Georgia Mikheil Saakashvili and the President of Poland Lech Kaczynski was passing by.
164. On 25 November, Abkhazian proxy irregulars entered village Pakhulani; they tried to count the number of existing population.
165. On 26 November, 2 Georgians were abducted from village Dirbi adjacent territories: Koba Khatashvili (b. in 1980) and Omar Mazmishvili (b. 1983). They were released after 1 week of detention.
166. On 27 November, the resident of Gali Irina Mebonia was kidnapped. On December 3rd, her dead body was found near village Nabakevi.
167. On 30 November, Ossetian militia opened fired at Georgian positions in village Plavismani.

## ***December***

168. On 2 December, fire was opened towards Georgian village Gugutiantkari, Gori district.
169. On 5 December, at 8:15 a.m. Ossetian militia fired from village Khelchua to Georgian police station in village Mereti. militia missed the target and damaged the premises of a neighboring house of a local resident.
170. On 10 December, at 06:00 a.m., a remote controlled explosive device exploded on Pkhveni Bridge, near village Nikozi, Gori district, while the officers of Shida Kartli Patrol Police were patrolling of this area. There are no casualties as a result of explosion although the patrol police car was damaged.
171. On 10 December, at 17:00 p.m. fire was opened towards the armored vehicle of the OSCE mission patrol. Fire came from the territory controlled by Ossetian militia, not far from village

Khviti, Gori district. The incident did not cause any casualties or injuries, although the vehicle was damaged.

172. On 12 December, early in the morning, Russian military troops left the territory of village Perevi for 8 hours. In order to ensure security and order, Georgian police started taking positions in the village. Backed by one APC and a platoon, Russian military troops returned to Perevi approximately at 17:00 pm and regained the positions, which they left in the morning.
173. On 13 December, at 09:00 am, Russian occupants, started reinforcing their positions in Perevi, they deployed around 300 airborne from 6 combat helicopters and moved mountain battalion to the village. Russian occupants, under the threat of opening fire to the units of Georgian Police deployed in the village, demanded from them to pull back from the village. Aiming to ease the rising tension, Georgian policemen had to withdraw from Perevi. EU monitors and observers from OSCE mission to Georgia, together with several EU ambassadors also witnessed the fact of re-entering Perevi village by Russian occupants.
174. On 17 December, at 21:00, Georgian police checkpoint in village Khurvaleti, Gori region, came under fire from automatic weapons from Russian occupied territory. As a result, one police officer Shalva Simonishvili was heavily wounded and placed in Gori hospital.
175. On 23 December, early in the morning, the family of Otar Gogokhia exploded on a mine (they were coming to Zugdidi in a horse carriage) near village Chuburkhinji. 4 persons were injured, two of them were brought to Zugdidi hospital, the other two were not allowed to go to Zugdidi by Russian soldiers. All the access roads, passes, bridges and other points are mined by Russians and Abkhazians, which threatens their lives and health in case of approaching so called borderline between Abkhazia and Georgia.
176. On 24 December, the heavy automatic fire was noticed on Ossetian side near village Koshka. In the evening, they shot several times at Georgian police positions, causing no damage or injuries.
177. On 27 December, at 23.30, Georgian police checkpoint situated in village Koshki, Gori district came under fire from the direction of Russian occupied territories. As a result the employee of Shida Kartli regional police of the Ministry of internal Affairs, Lavrenti Panchulidze was wounded;
178. On 30 December, at 21:00, the fire from automatic weapons was opened at a Georgian checkpoint in village Koshki. Nobody was injured.

### *January, 2009*

179. On 4 January, at 08:00 am Georgian police checkpoint situated in village Ganmukhuri, Zugdidi district came under intensive fire from Russian controlled territory, mainly from village Pichori, Gali district. Machine-guns as well as mortars were used. As a result of firing, no one was injured.
180. On 4 January, the family of Demur Kiria was robbed by the residents of village Tagiloni, Gali district. Demur Kiria was kidnapped and found murdered on 5 January.
181. On 8 January, at 05.00 a.m. Abkhazians and Russians opened fire from automatic weapons and grenade launchers towards Georgian village Orsantia. They fired more than 15 shells. The unexploded shells were found in the yard of Kvaraia family. The incident did not cause any injuries or casualties.

182. On 11 January, at 22:00 p.m. Ossetians and Russians opened fire at the police station in village Zemo Nikozi. Automatic weapons as well as grenade launchers were used. The incident lasted for 20 minutes. Nobody was injured.
183. On 13 January, at 23:00 p.m. Abkhazians and Russians attacked Georgian police checkpoint in Rukhi, from the direction of Chuburkhinji. Attack lasted for 20 minutes and was launched using automatic weapons. The incident did not cause any injuries or casualties.
184. On 14 January, at 14:20, Georgian police check point in village Koshka was attacked from Ossetian controlled territory in close proximity of village Disevi. Attack was launched from grenade launchers and automatic weapons. Incident did not cause any injuries or casualties.
185. On 16 January, approximately at 10:00 am as a result of firing from the Russian occupied territory, the employee of Shida Kartli Regional Police Main Division of MIA, Mamuka Kakhniashvili (Born in 1982) was killed on the territory of Georgian police checkpoint situated in village Knolevi. According to the investigation, the bullet was fired from a sniper rifle with a silencer.
186. On 18 January, at 05:00 am the Georgian Police checkpoint situated in village Koki Zugdidi district came under fire from the Russian occupied territory. The firing was conducted with machine-guns as well as mortars, as a result of which, the employee of Second Division of Special Tasks Main Division of MIA was wounded and consequently transferred to the hospital.
187. On January 19, at 17:00 pm a pickup police vehicle came under fire from the Russian occupied territory while patrolling near the Georgian police checkpoint situated in village Dvani Kareli district. The intensive shelling from Russian occupied territory was conducted with machine guns and lasted for 20 minutes. As a result of firing, several employees of the Ministry of Internal Affairs were shot and wounded, namely: Levan Gogilashvili, and Mamuka Janiashvili who were transferred to Gori military hospital.
188. On 23 January, early in the morning the resident of Gali Tengiz Akubardia tried to drive to Zugdidi from Gali in order to take his baby son to a doctor. He was requested to pay 300\$ by Abkhazians in order to let him drive through the checkpoint. He could not pay the amount and drove his car to his wife waiting for him on the other side of Enguri bridge. Abkhazians opened fire that caused injuries of one passenger in Akubardia's car.
189. On 24 January, in the afternoon, the fire was opened at the OSCE patrol monitoring the situation near Akhmaji. The incident did not cause any injures or casualties.
190. On 25 January, close to afternoon 2 Russian Mi-24s entered Georgian controlled airspace from Ergneti and flew over Georgian police checkpoints in villages Knolevi, Gogeti, Dvani, Nikozi, Ditsi, Khurvaleti and from Lamiskana and Akhmaji left for Akhalgori.
191. On 27 January, the 14-year-old Ioseb Khorkheli was injured in a result of a hand grenade explosion in the yard of school of village Kirbali. The boy got serious injuries and was hospitalized.
192. On 27 January, at about 14 p.m. fire was opened at Odzisi police checkpoint near the so-called administrative border with Akhalgori district. The incident took place when EUMM and OSCE were conducting patrolling near the site.
193. On 28 January, at 23:00 fire from automatic weapons was opened to Georgian police checkpoint on Enguri bridge, near village Rukhi. Incident did not cause any injures or casualties.

194. On 29 January, late at night, Russian soldiers were demanding food from Mebonia family in village Nabakevi, Gali district. The member of the family, Koba Mebonia resisted and was killed at the gate of his house. The body was taken by the soldiers in order to hide evidences.
195. On 31 January, at 11 a.m. EUMM monitors together with Lithuanian journalists were visiting village Shamgona in order to prepare a story about the explosion of the bridge in village Tagiloni, on the other side of Enguri river. Abkhazians and Russians shot several times from automatic rifles in the air, in order to disrupt the recordings. The incident did not cause any injures or casualties.

## ***February***

196. On 1 February, 4 Ossetians robbed Elguja, Suliko and Omar Budurashvilis, stole 140 Gel and a mobile phone.
197. On 2 February, at 15.00 Georgian police checkpoint was attacked from automatic rifles in village Knolevi from so-called South Ossetia. Incident did not cause any injures or casualties.
198. On 7 February, at 7:00 a.m. gunmen operating from the Georgian territory under Russian occupation assaulted a car moving on the main East-West highway and abducted Malkhaz Beuklishvili, an official from the Georgian Football Federation Mr. Beuklishvili was driven towards territory currently under Russian occupation in the stolen vehicle. The gunmen allied demand ransom in exchange of the hostage. Beuklishvili was released on February 8, in the evening.
199. On 7 February, in the evening, Abkhazian and Russian militaries wounded Zura Bobokhua near village Khurcha, who was trying to reach Georgia, controlled territories from village Nabakevi. He was taken to Zugididi hospital for treatment.
200. On 9 February, at about 23:30, Georgian police station in village Mereti was attacked from the Ossetian side. Automatic rifles were used during the attack. Incident did not cause any injures or casualties.
201. On 10 February, at around 10:30 a.m. armed South Ossetian militiamen kidnapped two monitoring officers of the OSCE mission in Georgia near village Adzvi, Gori district. The monitoring officers were held on the Russian occupied territory, in the town of Tskinvali. Later they were released.
202. On 10 February, at around 15:00, Georgian journalists from TV channels Imedi and 1st channel were detained by Ossetian Militiamen and released within half an hour.
203. On 11 February, at about 12:20 p.m. Russian occupying forces deployed about 50 personnel and 1 APC near in village Kvemo Nikozi, on Georgia controlled territories and blocked Georgian police checkpoint. They started building up fortifications.
204. On 12 February, at 20:00, fire from automatic rifles was opened at Georgian village Koda from Russian and Osetian controlled territories. Several houses were damaged. The incident did not cause any injures or casualties.
205. On 13 February, in the evening, 3 cleaner ladies exploded in Osiauri military base of a fuse. all of them received severe injuries and one lady has died of injuries in Gori military hospital.
206. On 13 February cattle, belonging to Nodar Maisuradze was stolen from v. Zemo Khviti. 4 robbers were of Ossetian origin and were armed with automatic rifles.

207. On 22 February, at 16:30, Georgian police station in village Knolevi has been attacked from South Ossetian side from Automatic weapons. Only police station has been damaged. The did not leave anyone injured.
208. On 26 February, about 50 residents of Gali district were forced to leave their houses and move to Ganmukhuri. The reason of the escape was the coercion and intimidation by Abkhazian militia and Russian militaries, who were demanding to hand over Irakli Bokuchava, resident of Gali who was injured on 25th of February and escaped to Zugdidi. By 16.00, Abkhazians and Russians brought about 30 APCs to Orsantia and Nabakevi, showing off the force and shooting in the air. They aimed to force Georgian side to handover Irakli Bokuchava.
209. On 26 February, at about 22:30, fire from automatic weapons was opened from the Ossetian side to Georgian villages Mereti and Gugutiantkari. The houses of civilians were damaged as well as one vehicle. The incident did not cause any injuries of casualties.
210. On 27 February 2009, at about 16:30 pm, members of South Ossetian proxy paramilitary forces attacked a car moving from village Koda in the direction of village Tchvrinisi, both in Kareli district (near the so-called administrative border) abducted its passengers: David Kapanadze, Irakli Kapanadze, Demur Tchigladze and David Sadzaglishvili and drove them towards the Russian occupied territory. Later, Irakli Kapanadze and David Sadzaglishvili were released. In exchange for the other two hostages David Kapanadze and Demur Tchigladze, which are since then held in the Tskhinvali prison, the Ossetian de facto authorities were at first demanding ransom in the amount of 6000 EU and later the release of South Ossetian criminals from Georgian prison: either Marek Dudaev (serving his sentence for multiple homicide) or Giorgi Zaseev (serving his sentence for participation in the terrorist attack on police station in Gori on February 1, 2005).

### ***March***

211. On 4 March, at 11:00 and 14:00 2 Russian helicopters Mi24 violated the cease-fire line over villages Ganmukhuri and Khurcha. They took pictures of Georgian police checkpoints and flew back to Abkhazian controlled territory.
212. On 4 March 2009, the so-called State Security Committee (KGB) of South Ossetia detained two persons: Tamar Charaeva (born in 1950, a teacher in Akhalgori school no.3) and Givi Chigoev (born in 1954, the chairman of the local district council). For several weeks, they were held in a temporary detention cell in Tskhivali. The proxy authorities charged them with "state treason" only because these persons have participated in the alternative South Ossetian presidential elections held on 12 November 2006.
213. On 5 March, at 10:45 a.m. 2 Russian helicopters Mi24 violated Georgian the cease fire line over villages Ganmukhuri and Khurcha. They took pictures of Georgian police checkpoints and fled back to Abkhazian controlled territories.
214. On March 5, at 17:00 Russian soldiers dropped plastic objects in a water collector near village Odzisi, which supplies drinking water to several villages. This objects blocked water supplies, after the expertise stated that these objects were polyethylene granules and could cause no harm to villagers, water supply was renewed.
215. On March 6, at 1:00 a.m. 7 Ossetians assaulted the herdsman in village Kvemo Atotsi and stole cattle, 12 cows. The incident did not cause any casualties.

216. On March 8, in the morning there was a heavy explosion in Akhlagori. It was caused by technical reasons in a warehouse of “Grad” launching devices and shells. The incident caused injuries of several Russian soldiers.
217. On 13 March, at about 23:30, the fire was opened at Georgian policemen near the police station in village Dvani. Fortunately, all of the police officers survived with no injuries.
218. On 13 March, South Ossetian paramilitary forces looted and burned the houses of ethnic Georgians in village Tsirkoli, Akhlagori district, namely the houses of Psuturi and Miladze families.
219. On 26 March, at about 14:00, Ossetian proxy militia opened fire at the villagers working in the fields close to village Ditsi. The incident did not cause any injuries or casualties.
220. On 27 March, at about 16:45, South Ossetian paramilitary forces opened fire from automatic guns towards village Mereti and then redirected fire at the Georgian police building. The incident did not cause any injuries or casualties.
221. On 27 March, South Ossetian paramilitary forces detained US citizen Chrstopher Chivers, the correspondent of New York Times newspaper in Georgia, , and later released him.
222. On 27 March, in v Tkviavi, Ossetians hijacked a car “VAZ 2101” (plate number PAO-204). The owner of the car is Demur Kherkheli (born in 1961), resident of village Kvemo Artsevi.
223. On 29 March, at 08:30, in the Georgian village Dvani a Georgian police pick-up that was conducting a routine patrol, was hit by a remote cotrolled explosive device. As a result of the explosion four employees of the Special Tasks Main Division of the MIA were seriously injured, namely: Otar Mkhitariani, Davit Peikrishvili, Avtandil Megrelishvili, Levan Taniashvili and Badri Jioshvili, who later died in the hospital. In order to assist the injured, two officers of Shida Kartli police, Vano Datashvili and Zurab Durglishvili, immediately arrived at the place of incident and also received severe injuries due to the activation of another remote controlled explosive device. Consequently, the injured police officers were transferred to Gori military hospital.

### *April*

224. On 6 April, in villge Tkviavi, a 14 year old teenager Giorgi Mariamidze found an unexploded shell in the local church yard. The shell exploded in his hands and the boy received serious injuries.
225. On 7 April, the military boat from Pichori has launched 3 granades to Georgian police check point in v. Ganmukhuri.
226. On 7 April, Abkhazian Militiamen have wounded 32 year old Vakja Lejava, who has delayed food supply to the occupants.
227. On 7 April, at about 23:00 the resident of v. Shashikura of Gali district Djansukha Abakelia has been shot in the yard of his own house.
228. On 7 April, 65 year old resident of v. Sida (Gali district) Gvandji Kuprava has been kidnapped.
229. On 11 April, there was a heavy explosion in Tskhinvali, details are not known.
230. On 12 April, Abkhazian militiamen have wounded a member of Sadjaia family in v. Lia (Tsalenjikha district), when robbing his house.
231. On 12 April, at about 23:00, 3 Ossetian individuals in masks have intruded the public school in v. Adzvi, who have beaten up the guard Jambul Khomasuridze and stolen 7 computers.

232. On 21 April, South Ossetian militia detained two OSCE monitoring officers for “border violation” and later released them.
233. On 22 April, in the morning hours, a mine exploded on a crop field near village Knolevi, Kareli district. No one was injured.
234. On 22 April, at 20:30, South Ossetian paramilitary forces opened fire at the Georgian police checkpoint near village Plavi, Gori district. No one was injured.
235. On 22 April, at 20:30 Ossetian militia opened fire to police check point in v Plavi.
236. On April 25, close to v. Odzisi, Georgian policemen have arrested the Russian citizen Valentina Bedoeva, who has illegally crossed Georgi-Russian border.
237. On 30 April, Georgian policemen have arrested 28 year old Vadim Eloev, resident of v. Orchosani, Akhlagori district, who had an attempt to hijack police car on Tbilisi-Gori highway.

### **May**

238. On 2 May, the resident of Zemo Khviti, David Bughdavanidze has left his home after the family conflict in drunken condition. Few hours later his relative found out that person is detained in Tskhinvali jail.
239. On 3 May, Zurab Shaverdashvili, the resident of v. Kveshi, who was drunk, has crossed so called border line to South Ossetia. He was driving his tractor and was detained by Ossetians.
240. On 7 May, at about 19:50, the residents of Mereti have heard noise of explosion and saw smoke over v. Khviti (on Ossetian side). Later there was a heavy explosion on farming lands of v. Mereti.
241. On May 1, 5 and 8 EUMM monitors were threatened several times close to Dvani. The fire from automatic rifles was opened in the air. Later Ossetian side has explained the incidents as the vehicle of EUMM was by mistake taken as Georgian cobras.
242. On 9 May, 9 year old Mate Salia found unexploded ordnance close to tea plantation in Tsalenjikha, while looking for metal scrap. After the explosion kid has received serious injuries.
243. On 11 May, Ossetian militia have hijacked car “Uaz” with state plate numbers OAZ-521 from v. Chorchana of Khashuri district. The owner of the car is Ramaz Samkharadze.
244. On 12 May, in v Chvirnisi of Kareli district, Kareli resident Egna Valiev has taken Vladimer Kharazishvili (born in 1960) to the direction of Znauri. Vladimer has not shown up afterwards, presumably, he is in Znauri and abductors are asking for ransom.
245. On 15 May, at about 19.00 3 drunk Ossetian militiamen have approached the Georgian check point in Ergneti, they were holding machine gun and were swearing. After the involvement of col. Tarasov and Russian occupying forces representatives, Ossetians went back to Russian controlled territories.
246. On 19 May at 2:00 a.m. one drunk Russian officer and one drunk soldier were arrested by Georgian police in v. Tvauri, Kaspi district. At 9:00 a.m. they were handed over to Russian occupying forces at Ergneti check point. The arrested Russians were questioned in presence of EUMM representatives, whose representatives also followed the handing over procedure.
247. On 28 May, 2 herdsmen Tristan Maisuradze and Tamaz Markozashvili and their 12 cows. They were released in few hours, but without cattle.
248. On 28 May, at about 20:00 in the evening, the Georgian police building in Koshka was attacked from v. Disevi. AGS shell has damaged water tank that is used by police station for water supply.

249. On 29 May, at 7:30 a.m. police car has been attacked from automatic rifles on a road from Lamiskana to Sakorintelo. Incident didn't cause any injuries or casualties.

### **June**

250. On 2 June, between 3:00 a.m. and 4:00 a.m. the railway bridge connecting Khoni to Ingiri was exploded. TNT with time mechanism was used for explosion. The incident occurred 2 hours earlier before passenger train had to cross the bridge.
251. On 2 June, at 10.30 Russian helicopter Mi-8 was flying over village Khurcha for 15 minutes.
252. On 3 June, at about 14.00 Russian helicopter mi-8 has entered Georgian airspace from the direction of Vladikavkaz, it made a circle over Gudauri and left for Akhlagori.
253. On 6 June, at about 14:00 Ossetians have stolen cattle from v. Zemo Nikozi.
254. On 7 June, 50 Ossetians with 2 APC have appeared in v. Perevi, 15 of them have remained there. They stole cattle from local population.
255. On 8 June, Ossetians have stolen 2 caws from Georgian population in v. Kardzmani.
256. On 8 June, at night, so called Abkhazian security forces have illegally detained mother with 2 infants from v. Dikhazurghi, who are members of Kharchilava family. They are requesting to handover the member of their family Soso Kharchilava.
